TOURNAMENT RULES & REGULATIONS

1. ELIGIBILITY. Open to all Michigan and Canada USBC Adult members. Bowlers may establish eligibility by paying all applicable dues. Refer to USBC Rule 300c.

2. AVERAGES: a.) Highest verifiable 2025/26 league average of 21+ games. b.) Highest current average with at least 21 games. c.) If no certified average, bowler will use **220**. *Use of the 10 Pin Rule is in effect.* Failure to use correct average shall disqualify scores if submitted averages are lower than correct average.

3. MULTIPLE PARTICIPATION: *Unlimited entry is permitted for Team and Doubles/Singles but singles, doubles with same bowlers and teams with more than 3 same bowlers can only cash once. Contestant's FIRST score in an event shall count toward their "All Events" Total.*

4. PRIZE FEES: Prize fees are returned 100% within each event. Team, Doubles/Singles prize ratio 1:10. All Events prize ratio will start as 1:15. In the case of a tie for any position standing, position prizes will be combined and split equally. *Payouts will be mailed to team captains.*

5. REPORTING PRIZE WINNINGS: Bowlers must report prize money won in excess of **\$300.00** in ALL tournaments competed in within the previous 12 months.

6. ENTRY & DEPOSIT FEES: **Confirmed** reservation fee of \$50.00 per team will hold squad place. Full entry fees due no later than 2 weeks prior to bowling. Cancellation requests less than 14 days before squad will be assessed \$50 fee.

7. HANDICAP: 90% for each bowler per event from 220 scratch.

8. LINEUP CHANGES: Lineup changes **MUST** be due to Tournament Director a least 24 hours prior to squad. Substitutes will be permitted if available for emergency/disability situations after team or doubles/singles events have started. Combined scores to count and player subbed out **CANNOT** return.

9. EVENTS PARTICIPATION: Bowlers entering Singles must first enter Doubles. Doubles & Singles will be bowled on the same lane pair. Bowlers entering all 3 events will be *automatically enrolled* in All Events.

10. APPEALS/PROTESTS/DISPUTES: Any appeal or protest shall be made in writing prior to payment of prizes. The Tournament Director will settle all disputes not covered by USBC.
